Learning Packages

Learning Packages	As we go through the New Hire Training program, main call scenarios are chunked into Learning Packages. Each Learning Package contains two call scenarios.
	These call scenarios contain a primary skill set along with secondary skills that are directly related to that primary skill.
	For example, the primary call type may be related to payments. The secondary skills that you will learn will be address changes, explaining myWireless account to customers and other related topics.
	We have set up this training program to present these Learning Packages in several formats in order to suit several different learning styles. You choose the method for learning that works for you. You will also work at your own pace within the time allotted for the lesson.
	The Learning Packages content is setup on the New Hire Portal. Each Learning Package lesson material will consist of:

	Competency documents
